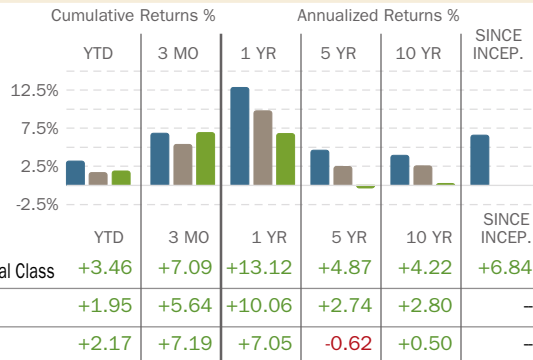

**PERFORMANCE RETURNS** 1,2

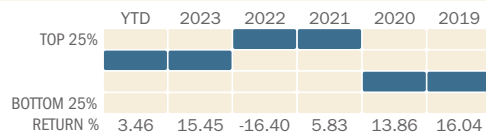

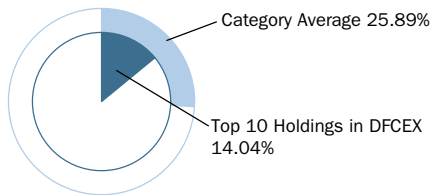

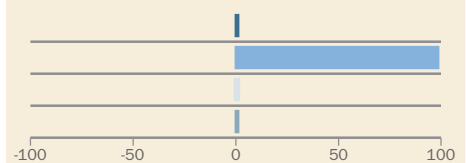
